AWARD: Scholarships in the amount of \$1,500.00 will be awarded annually to students enrolled in the study of Agriculture or an Agriculture related field.

ELIGIBILITY: The applicant must be a high school senior or not beyond the freshman year in college.

The applicant must have successfully passed their high school academic requirements and have college entrance exam scores qualifying their admission to an accredited Georgia college.

Applicant must be a Georgia resident and live in a rural county.

Applicant must be pursuing a degree directly related to agriculture.

REQUIREMENTS: All portions of the application must be filled out completely, clearly and honestly. All requested items must accompany the

application. Any omission or misrepresentation will result in disqualification.

Each application must be accompanied by *three* letters of recommendation: 1) County Extension agent or Vocational Teacher 2) High School or College Teacher 3) Community Leader (other than a family member).
