#### About the Scholarship

Becky Strickland Echols was one of the most giving individuals one could ever know. She gave of herself unconditionally to her family, friends and community.

Mrs. Echols graduated from Hiram High School in 1968. After attending West Georgia College, she began her career in banking as a teller in 1978. From there she forged new opportunities for women in business and was eventually named the first female to sit on the Board of Directors at the First National Bank of Paulding County. Through numerous acquisitions, she was promoted within the company many times and ultimately named President of Regions Bank West Metro, again the first female bank president within the Corporation.

In addition to her achievements in the banking industry, Becky was also a leader in Paulding's business community. She served as President of the Paulding County Chamber of Commerce and was named their Business Leader of the year in 1990, the first year the award was given. Later, the Paulding Chamber honored her again with Citizen of the Year, an award her father Ben Hill Strickland received in 1973. She is currently the only person to ever receive both honors from the chamber.

Becky Echols was a person of high ideals whose friendship was cherished by all who knew her. She worked hard to foster growth and positive change in her community and will be remembered and greatly missed by her family and friends. The purpose of this scholarship is to award deserving students the opportunity to further their education in honor of Becky Strickland Echols.

Becky Echols had a unique gift of touching the lives of those she came in contact with, and a light will always shine in those lives she so specially touched. It is our hope that the recipient of this scholarship will be an example of that eternal light that will always be Becky.

#### Awards/Funding

Awards will be made in an amount established by the trustees of the fund. Funding for this scholarship is obtained through contributions from local organizations and individuals. Donations may be in the form of cash, bonds, stock, etc. All local associations are encouraged to make annual contributions. Current policy determines the amount of scholarship funds to be disbursed in any fiscal year.

#### **Application**

#### Applicants must:

- 1. Be a graduating high school senior accepted by an accredited post-secondary institution or a certified technical school, or be enrolled already at such school;
- 2. Have at least a grade average of "C" at the time of application; and
- 3. Complete the application and mail it to the above address on time.

#### Selection

There are four trustees of this scholarship. The trustees, also comprising the scholarship selection committee, meet throughout the year at board meetings. Scholarships are awarded on the basis of academic excellence, community service and activities, career goals, a letter of recommendation, and financial need. #### Additional Information/Criteria for The Becky Strickland Echols Memorial Scholarship

- 1. Applicants may be considered for scholarship support only if they will be entering or are in their continuing years at an accredited post secondary institution or a certified technical school.
- 2. The Scholarship board must receive applications no later that March 1<sup>st</sup>. Scholarships shall normally be awarded annually to begin the fall quarter/semester of each school year.
- 3. Scholarship amounts may vary. Awards may be made to cover actual training cost for full-time study in an accredited post secondary institution or an accredited technical school or to a level determined by the Scholarship's Trustees. Scholarship funds may be applied to cover actual expenses for tuition, fees, books, and special supplies. Costs for room/board may also be covered. Scholarship funds may only be applied toward actual expenses for items considered reasonable or routine for any student enrolled in the same program of study at the same institution.
- 4. Scholarships are non-renewable.
- 5. Applicant must have at least a grade average of "C" at the time of application, and must maintain this "C" for each quarter of study completed in order to remain on scholarship during subsequent quarters. Confirmation of a student's quarterly grades and grade average must be provided to the Scholarship by means of an official school grade report or transcript.
- 6. Scholarship awards shall be made with the expectation that the student will remain enrolled in full-time study through consecutive quarters or grading periods (Summer Quarter/Semester study not required). Any interruption in this method of continuos enrollment must be justified in writing to the Scholarship Board. Any unjustified interruption in the student's full-time study schedule may result in cancellation of the student's scholarship approval.
- 7. Applicants <u>must</u> provide copies of S.A.T./A.C.T. scores, high school and/or college transcripts. If a student has participated in a joint enrollment program and or A.P. level courses, grades will be considered accordingly and these grades should also be included as transcripts.
